## Visible Problems With ELAP

- 1) The regulations are badly out of date and unenforceable
- 2) The fees are inequitable
- 3) The budget insufficient to support the program
- 4) The On-Site Assessments (OSAs) are inconsistent between assessors and inconsistent with existing standards
- 5) Performance Testing Samples (PTSs) are not being assessed
- 6) Record Handling and Management disorganized process for handling paperwork, lack of standard procedures.

### Article 6. Required Test Methods

### §64811. Test Methods.

- (a) Laboratories certified for any Subgroup within Fields of Testing 1 through 6, as identified in Section 64823, shall employ those methods found in 40 Code of Federal Regulations Part 141 as amended July 17, 1992, 57 Federal Register 31776.
- (b) Laboratories certified for any Subgroup within Fields of Testing 9 through 14, as identified in Section 64823, shall employ those methods found in Article 5, Section 66260.11, Title 22, California Code of Regulations.
- (c) Laboratories certified for any Subgroup within Fields of Testing 8 or 16 through 19, as identified in Section 64823, shall employ those methods found in 40 Code of Federal Regulations Part 136, amended September 11, 1992, 57 Federal Register 41830, or methods stated in any permit issued by a California Regional Water Quality Control Board. If no method is stated in the permit and there is no method cited for the substance in Part 136, the laboratory is to seek approval for the use of the method from the Regional Board issuing the permit.

- Contractors Still Need to be Obtained, Trained, Maintained.



- 1) If it is Not Cost-Effective to Hire More Staff, It will Not be Cost-Effective Retain More Contractors.
- 2) Contractors are not Cheaper than Staff



## Standardized OSAs

- **ELAP Does not Have a** Standardized OSA Procedure
- There is No Way to Know How 2) Many Staff or Contractors are **Needed without Knowing How Much Staff Time is** Needed to Conduct an OSA

# There is No Federal or State Law Requiring an OSA Every Other Year

§ 142.10 Requirements for a determination of primary enforcement responsibility. A State has primary enforcement responsibility for public water systems in the State during any period for which the Administrator determines, based upon a submission made pursuant to §142.11, and submission under §142.12, that such State, pursuant to appropriate State legal authority:

. . .

(3)(i) The establishment and maintenance of a State program for the certification of laboratories conducting analytical measurements of drinking water contaminants pursuant to the requirements of the State primary drinking water regulations including the designation by the State of a laboratory officer, or officers, certified by the Administrator, as the official(s) responsible for the State's certification program. The requirements of this paragraph may be waived by the Administrator for any State where all analytical measurements required by the State's primary drinking water regulations are conducted at laboratories operated by the State and certified by the Agency. Until such time as the Agency establishes a National quality assurance program for laboratory certification the State shall maintain an interim program for the purpose of approving those laboratories from which the required analytical measurements will be acceptable.



## Change the ELAP Regulations

Article 2 Certification and Amendment Process.

### Section 64803.

(a) Certification. A laboratory and its auxiliary or mobile laboratories shall be certified for a 24 month period in the Subgroups within each Field of Testing applied for when all the following have occurred:

100834. (a) In order to carry out the purpose of this article, the department may do all of the following:

(1) Enter and inspect, on an announce or unannounced basis, a building, premises, equipment, materials, records, or information at a reasonable time to secure compliance with, or prevent violation of, this article or the regulations adopted pursuant thereto.


